The Bank Account Reconciliation was read. The ending balance for November was \$273,856.72. The Security Financial Bank Statement for November was verified by the Board.

Supervisor Manor was contacted by the Wagner's about a log placed across a driveway by the neighbor. They said UPS and FedEx use that driveway. Supervisor Manor checked the site. The driveway was on the neighbor's land and the log was not in the Town's right of way.

## **Plan Commission Report**

Plan Commission member Maureen Manore reported that the Plan Commission is following up on a report that conditional uses need to be spelled out in the zoning ordinance. They also want to look into planned use development. Other than that, most of the revision is complete.

## **Road Reports**

The road certification map has been signed and submitted.

Chair Anderson spoke to Alan Olsen, Milestone Materials, about rock crushing at the Anderson quarry. Before they can crush rock, they would need to hire a stripping crew to remove the soil and then blast the rock. The Town would need to commit to a 20,000 ton minimum costing approximately \$170,000. Supervisor Anderson will provide more information at the next meeting.

## Sale of Town Property – Garage and Lot

The Board examined the deed for the property and determined that there were no stipulations against the Town being able to sell it. The next step is to get permission to sell from the town electors at the Annual meeting.

#### **Durand Ambulance Contract Renewal**

The 2023 contract with Durand Ambulance was examined by the Board. Motion by Supervisor Manor, seconded by Supervisor McDermott, to accept the 2023 Durand Ambulance Contract. A voice vote was held. Motion carried with no negative votes.

### **Board of Adjustment Appointment**

Chair Anderson re-appointed Cindy Schultz to the Board of Adjustment for a three-year term. The Board confirmed the appointment.

### **Set Caucus Date**

The date for the caucus was set for January 10, 2023, 6:30 p.m.

### **Approve Payment of Bills**

The Board approved the payment of bills paid by checks 11265 through 11281 for a total of \$16,109.69. Chair Anderson signed the approval of payment form.
